Makerspace: The Maker Nexus makerspace provides access to 3D printers, laser cutters, home and industrial textile equipment, an electronics bench, a comprehensive woodworking shop, a computer lab, meeting space and the beginnings of a metalworking shop. Maker Nexus members pay a monthly or annual fee for access to all the makerspace tools and equipment for their own projects. Our experienced staff maintains the machines in excellent working order and are always available to lend a hand or provide advice on how to effectively use a tool. At the beginning of 2020, Maker Nexus had 180 members. Membership growth was hampered by the 3-month closure of the makerspace due to COVID-19 restrictions and continuing capacity restrictions for the remainder of the year, but membership increased to 200 by the end of 2020.

4b (Code:) (Expenses \$ 122,761 including grants of \$) (Revenue \$ 70,292)
Education: Maker Nexus fulfills its educational mission through formal skill-building sessions, informal learning opportunities, and STEAM (Science, Technology, Engineering, Mathematics plus Arts) enrichment programs that emphasize inquiry and problem-based learning methods used in the creative process. Maker Nexus offered 43 different types of skill-building and enrichment sessions in 2020 with 677 total enrollments. Sessions ranged from instruction on basic operations and safety for equipment to projects involving design and prototyping.

4c (Code:) (Expenses \$ 327,397 including grants of \$) (Revenue \$ 18,739)
COVID Response: Personal protective equipment was in extremely short supply at health facilities in the early months of the COVID-19 pandemic. Maker Nexus staff and members looked hard to see how we could help. We were able to rapidly design and prototype a useful face shield in cooperation with local doctors and hospitals. With our shop closed to members, we began making this design with our otherwise-idled laser cutters and 3D printers. Requests for face shields came pouring in from health facilities in our area and across the country. To increase production, we coordinated over 450 volunteers with home, school, or company equipment who created parts to our design and brought them to our facility for assembly and distribution. Our makerspace was transformed into a production hub, with inbound materials, finished parts and outgoing shipments taking up most of our workshops and office spaces. By mid-June, the general availability of PPE had improved, so we began ramping down the COVID-19 response effort. By the end of June, we had responded to 588 requests, delivering 55,709 face shields. Our overall effort finally wrapped up at the end of the year with a grand total of 82,396 face shields donated to health facilities.
